Statement of Need

Special Education Services

Kinexus Group as the Educational Service Provider (ESP) for the BA of SWMI is seeking proposals from qualified bidder to provide a special education teacher, speech and language services, part-time para pro services and special education coordination services for the 2025-2026 school year. As the ESP for BA of SWMI, Kinexus Group is responsible for staffing and securing contracted services on behalf of the board of directions for this Public School Academy. Staff training and professional development begins on August 11, 2025 and students return on August 25,2025. June 4, 2026 is the last day of school. The company or individual would supply special education instructional and speech services for 9-12 grade high school students and work collaboratively with Berrien RESA to serve students who have an IEP. This work requires consistent, professional and accurate communication with school staff, families and students.

Full Time services may be required, based on enrollment. Bidders should have capacity to be full time if needed.

Scope of Services

Delivery of special education services:

The Special Education Teacher is the expert in virtual related curriculum by coordinating, planning and executing instruction for both general education and special education students and serves as the formal Special Education Coordinator. Additionally, this position provides focused support to students and create a positive, flexible, and productive environment both in-person and in a virtual setting. The Special Education Teacher works in collaboration with the School Leader, teachers and Student Success Team to ensure a high-quality experience for students and their parents/guardians.

WHAT WE EXPECT FROM YOU:

- Guide and facilitate students through online curriculum; support students in-person preferred but also virtually if necessary.
- Have multiple conversations with students each week encouraging the students to stay on task. This would include two-way communication requirements.
- Serve as Special Education Coordinator at Bridge Academy of Southwest Michigan, through partnership with Berrien RESA.
- Responsible for reporting, Medicaid tracking and billing
- Maintaining Illuminate tracking platform.
- Ensure FAPE during the student enrollment process.

- Collaborate with students, parents, and other members of staff to develop IEP through the ARD Committee process for each student assigned.
- Implement an instructional, therapeutic, or skill development program for assigned students and show written evidence of preparation as required.
- Plan and use appropriate instructional and learning strategies, activities, materials, and equipment that reflect understanding of the learning styles and needs of students assigned.
- Work cooperatively with classroom teachers to modify regular curricula as needed and assist special education students in regular classes with assignments.
- Present subject matter according to guidelines established by IEP.
- Employ a variety of instructional techniques and media to meet the needs and capabilities of each student assigned.

Budget Amount and Contract Period

Budget amount should be based on special education population of 20 students per school year. The contract shall be for one year and may be renewed for additional years based on review.

Bidder Qualifications

To be considered for award of this RFP, the proposing individual or company must meet the following minimum qualifications and:

- Bachelor's degree.
- Valid Michigan Teaching Certificate with Special Education endorsement. Except as otherwise provided by law, the Academy shall use certificated teachers according to state board rule.
- Experience with Illuminate (or similar platform) and willingness to learn platform of the local RESA.
- Teachers must be strong customer service leaders for students, families, and community members.
- Understand the use of technology in both instructional and operational settings.
- Ability to initiate and complete tasks with self-direction in a timely manner.
- Comfort with onsite and virtual instruction.
- Satisfactory performance ratings in delivery of instruction and classroom management.

Proposal Requirements

Kinexus Group reserves the right to request additional information for clarification purposes or to allow corrections to errors or omissions provided errors or omissions do not provide a competitive advantage to any proposer.

- 1. By signing and submitting this proposal, the prospective recipient of Federal assistance funds is providing the certification as set out below.
